	12	Minimum scores and/or rubrics must be included in the initial course overview for each assessment	Are score expectations for each assessment included in the course introduction? Are the expectations clear?
	13	Learner must receive scores and feedback on assessments, regardless of type of assessment	How will users receive scores and feedback? Will these methods support continued learning?

	15	Course provided by reputable vendor (widely accepted as experts in related field)	Does the vendor have an established history of reliabilty? Is the vendor recognized as trustworthy by other reputable organizations?
	16	Learner maintains agency over parties with access to his or her microcredentials, whether in progress or completed	Can the user control when, where, and with whom coursework and badges are displayed or shared?

	19	Received expeditiously according to time in course outline	When will users receive digital badges? Is this timeline shared clearly in the course overview?
	20	Academic or continuing education credit awarded to learner	Will the user be provided CEUs or other credits based on successful course completion? Are details about continuing education hours and attainment available for the user in the course overview?
